

RESOLUTION No. 13875

**A RESOLUTION OF GARFIELD COUNTY, WASHINGTON
ESTABLISHING FEES AND CHARGES**

WHEREAS, the Garfield Board of County Commissioners has determined that it is in the best interests of the County to provide a single, efficient and convenient listing of fees and charges; and

WHEREAS, such a listing will better facilitate the updating and uniform review of all such fees and charges on a periodic basis; and

WHEREAS, previous Resolutions that provide for fees and charges are hereinafter superseded;

NOW, THEREFORE BE IT RESOLVED BY THE GARFIELD BOARD OF COUNTY COMMISSIONERS THAT THE FOLLOWING FEES AND CHARGES BE ESTABLISHED:

Section 1. LEGAL NOTICES AND SITE POSTINGS. For all applications and permits whereby a legal notice and/or site posting is required, the applicant shall be responsible for the full costs of said items. The applicant shall use forms prescribed by the County for legal notice and/or site postings and shall prove by receipt or affidavit of the publisher that said legal notice has been paid before the application shall be considered complete.

SECTION 2. FEES. The fees listed in this Resolution are for the item listed and do not include separate Environmental Assessment fees, if such are applicable.

SECTION 9. ACTUAL COST FEES. For applications/processes noted above which require actual cost fees, the process shall be as follows:

- a) Actual Costs are defined as **all costs** incurred by the County in receiving, reviewing, and processing the Application, EIS, and/or Appeal, as described in the County's Planning Ordinances and Regulations.
- b) Applicants will submit an application, EIS, or Request for Appeal along with a check for the required deposit. Deposit monies must be submitted within three days of submittal of the C.U.P. Application, EIS, or Request for Appeal.
- c) The application is given a project number and pertinent information about the applicant is entered into a computer database along with check information and amount.
- d) A trust account is created with the applicant's check.
- e) A project file is set up in a tracking system which keeps track of the hours and purpose which County staff work on any given project.
- f) Monetary values of the hours worked by a planner are periodically deducted from the trust account.

- g) When the project has been approved or denied and closed out by the planning staff, any money remaining in the trust account will be refunded to the applicant. Occasionally, more complex or problematic projects will exceed the deposit amount and the applicant will be asked for additional funds for the trust account.
- h) DETERMINING DEPOSIT AMOUNT:
- a. APPEALS: \$2,500 deposit, must maintain a \$500 balance;
 - b. EIS PROCESSING: \$5,000 deposit, must maintain a balance of \$1,500;
 - c. CONDITIONAL USE PERMIT before Hearing Examiner (Not Wind-tower project): \$5,000 deposit, must maintain a balance of \$1,500;
 - d. WIND-TOWER Project: \$30,000 deposit, must maintain a balance of \$5,000. The parties may further define the deposit account so long as the initial deposit amount is no less than \$30,000 and the balance of the account is maintained at \$5,000.

SECTION 10. Superseding Effect. The fees and charges established in this Resolution shall supersede all previous fees and charges adopted by previous resolutions to the extent that the same are inconsistent herewith.




